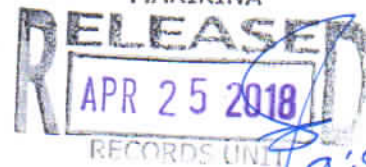

- e. Proposals for TDC-NCRTAA (if any)


