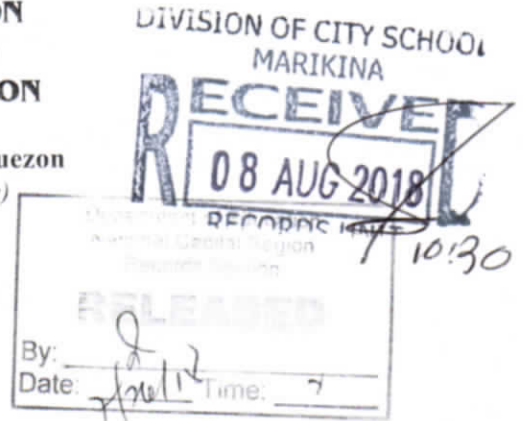

The field is hereby informed that before the expiry of the Collective Negotiation Agreement (CNA) of DepEd-NCR with ACT-NCR Union, a petition for certification election challenging the representation of ACT NCR Union as the Sole and Exclusive Negotiating Agent (SENA) academic for rank and file/teaching personnel was filed by the Teachers Dignity Coalition- NCR Teachers' Union and DepEd Teachers Union. The same was dismissed in an Order dated June 28, 2018 by the Bureau of Labor Relations of the Department of Labor and Employment. However, this Office was informed by IDC-NCR Teachers' Union that an appeal was filed.

Pending resolution of the appeal, DepEd-NCR panel will negotiate with ACT NCR Union which is still considered the Sole and Exclusive Negotiating Agent (SENA) for academic rank and file or teaching employees within the Region.
