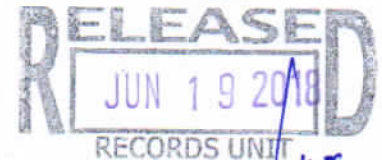

Immediate and wide dissemination of this Memorandum is desired.

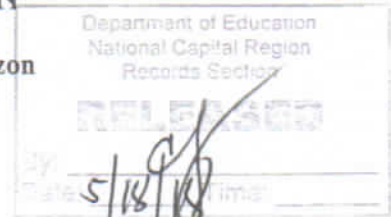

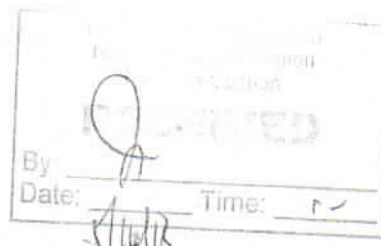
