ADVISORY

Administration of the National Achievement Test for Grade 12 for School Year (SY) 2017-2018 to Non-Sampled Schools

1. Pursuant to DepEd Memo 68, s. 2018 entitled *Administration of the National Achievement Test for Grade 12 for School Year 2017-2018*, the Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of schools divisions and secondary schools personnel, shall administer a second round of **NATG12 test administration to the Non-Sampled Schools for SY 2017-2018**. The test administration date will be announced through a DepEd Memorandum.
2. Students who failed to take the test in the first round shall also be allowed to take the test in the second round of NATG12 test administration.
3. DepEd Central Office shall deliver and retrieve the Answer Sheets (ASs) from the respective Schools Division Offices (SDOs). The Test Booklets (TBs) used in the first round shall remain in the SDOs and be utilized for the second round of test administration. The forwarder of the test materials shall retrieve the TBs and ASs used in the first round, one week after the test administration of the second round.
