

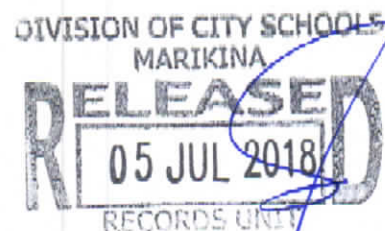

**DIVISION MEMORANDUM**

**THE ADMINISTRATION OF THE REVISED  
 PHILIPPINE INFORMAL READING INVENTORY**

**TO:** Chief Education Supervisors, CID and SGOD  
 Elementary School Principals  
 Officers-in-Charge  
 Public Schools

- In accordance with DepEd Order No. 014, s. 2018 which is the "Policy Guidelines on the Administration of the Revised Philippine Informal Reading Inventory, this Division will spearhead the simultaneous conduct of Phil-IRI (Pre-Test & Post-Test) in all elementary schools.
- This activity aims to:
  - measure and describe the learners' reading performance in both English and Filipino languages in oral reading, silent reading and listening comprehension;
  - determine every learner's independent, instructional and frustration levels;
  - serve as one of the bases in planning, designing/redesigning the reading instruction of the teachers and the school's reading programs and activities to improve the overall school's reading performance;
  - obtain accurate results on the readability levels of the learners.
- The reading materials and various forms to be accomplished will be provided by the target school.
- The **Phil-IRI Oral Reading Test (ORT)** will be conducted on **opposite sessions** with the following schedule to avoid disruption of classes:
  - O.R.T Filipino - Gr. 3 to 6 pupils
  - O.R.T English - Gr. 4 to 6 pupils

7. The conduct of the Phil-IRI (Post Test) which is scheduled on February, 2019 will be administered and monitored by the **same** group of teachers and supervisors.
