RODOLFO B VALENTINO SR., D.M.D., On 15 September 1999, The Sangguniang Panglungsod ng Marikina enacted City Resolution No. 221 Series of 1999 entitled "*Resolution Recognizing the Civic Action Team's invaluable role in the celebration of the Marikina Police Memorial Day*" recognizing and commending our organization's invaluable role as it singlehandedly spearheaded the annual celebration of the Marikina Police Memorial Day since 1990, until the City Government of Marikina under the leadership of Hon. Engr. BAYANI FLORES FERNANDO joined in the yearly commemorative activities, which was approve unanimously by the then City Council and by then Acting City Mayor Hon. DEL REYES DE GUZMAN. On the latter years it was decided to commemorate said event every 2<sup>nd</sup> Sunday of September of each year.

The program itself is attended by numerous offices, organizations, groups, and schools citywide with an estimate of a minimum number of a thousand participants for each year the program is being conducted. We've had Guests of Honor for the past years such as Secretaries of Interior and Local Government, Chiefs of the Philippine National Police (PNP), then MMDA Chair Atty. Dante Agudo Gierran, CPA.


For this year, our Guests of Honor will be the Members of our Marikina Police Retirees Association headed by their President PSSUPT ELY PINTANG PNP Ret., and the Familles of our Fallen Policemen. It is our aim for this year to go back to the very meaning why this once in a year program is being commemorated which is to honor and remember those who once served our City as Law Enforcers.
