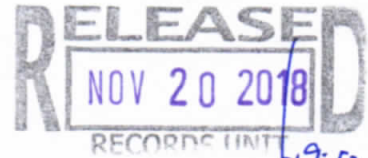

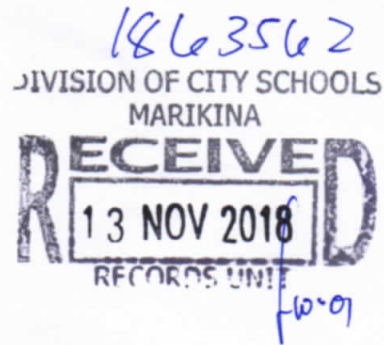


This has reference to the implementation of Pantawid Pamilyang Pilipino Program in National Capital Region.

The Department in partnership with the Department of Education through *DepED Memorandum no. 090 series of 2018* will be conducting a field testing on capturing learner's reference number (LRN) in order to develop a more efficient monitoring tool of the education conditionality of the program. DSWD's *Pantawid Pamilya Information Systems* will now be collecting the Learners Reference Number for each child beneficiary, subject to the provisions of Republic Act No. 10173 also known as the Data Privacy Act of 2012. We will be using the Learner Reference Number (LRN) Validation Form. This form will be distributed to schools with *Pantawid Pamilya* Beneficiaries to ensure that each registered child-beneficiary currently enrolled in public/private, formal/nonformal and/or Alternative Learning System Learning Institutions will have an updated information database to include the *Pantawid Pamilya* Member ID, and the LRN.

In this regard, we would like to inform you that we will be visiting the school facilities in your locality to collect the LRN of the *Pantawid Pamilya* student members from October to December 2018 anytime between 8AM-5 PM. An orientation will be conducted for school administrators prior to the visit by DSWD *Pantawid Pamilya* staff assigned in your facility to ensure proper accomplishment of LRN forms and facilitate agreements on the collection and submission of accomplished forms. The Learner's Information System (LIS) Administrator will facilitate in capturing LRN with the help of Facility Focal Person.

Our staff, Mr. Jaere Medina with Tel. No. 310-1432 or CP No. 09177029380 will closely coordinate with you regarding this matter.
