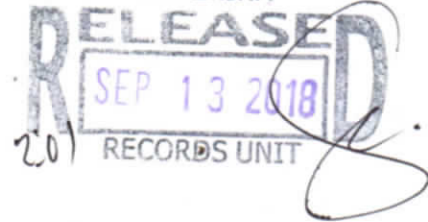

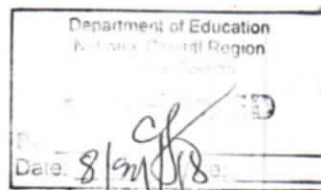
MEMORANDUM

TO : Schools Division Superintendents

RE : DepEd Employees' Due and Demandable Loans with GSIS

DATE : August 29, 2018



1. Per Memorandum No. OUFDA-2018-0011 of Undersecretary Victoria L. Medrana-Catibog, there are 122,926 DepEd employees who availed of different GSIS loan products that are already in default. An alternative to settle the past due loans, to make it current/updated, is to apply for the GSIS Enhanced Consp-Loan Plus Program, wherein the penalties and surcharges will be automatically waived by the GSIS. However, the **"automatic waiver" of the GSIS will be discontinued effective October 1, 2018.**
2. In this connection, Schools Division Superintendents are hereby directed to immediately, without delay, inform the teachers whose names are in the list, through the school heads, to settle in full their due and demandable loan accounts to the GSIS before October 1, 2018, to avoid compounded penalties and surcharges that may adversely affect their retirement benefits.
3. Attached hereto is the Compact Disc containing the names of employees per Division. The provision of the Data Privacy Act shall be observed in handling the personal information contained therein.
