



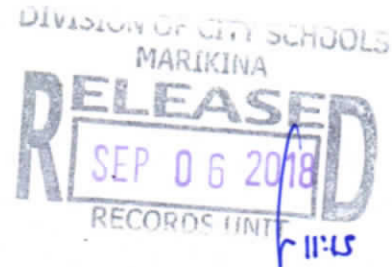

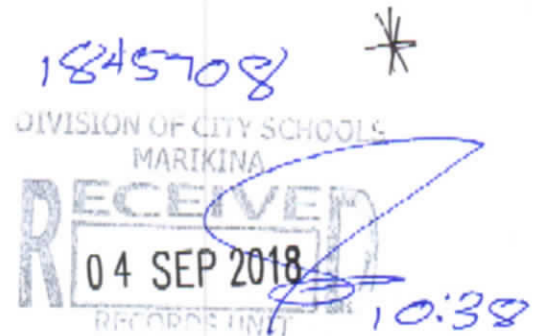

Attached herewith is our legal basis regarding the said request.


