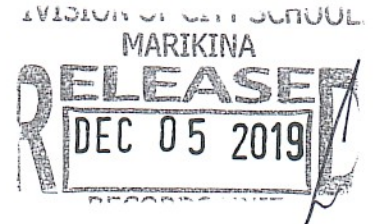

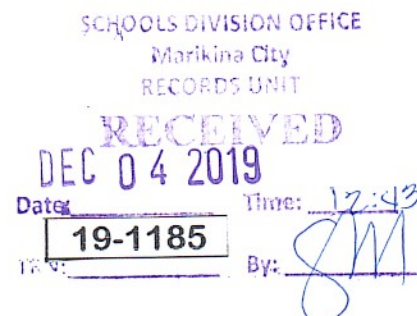


This is the first time for the cooperative movement to join the parade and show its force as per request of Hon. Mayor Marcy Teodoro.
