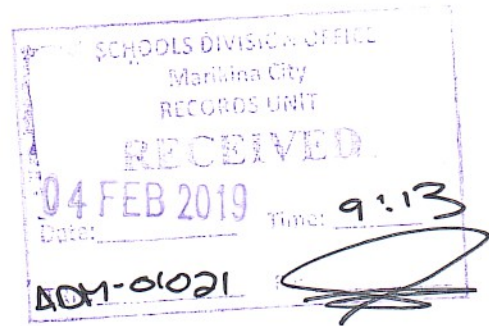

3. Participants:
