For the succeeding school year 2021-2022, please be informed that this Office shall strictly implement deadlines as set in the policy. This is to ensure that applications are promptly acted and ample time is given to private school administrators to proactively prepare prior to the opening of classes. As such private school focal persons are requested to communicate these periods observe for SY 2021-2022.
