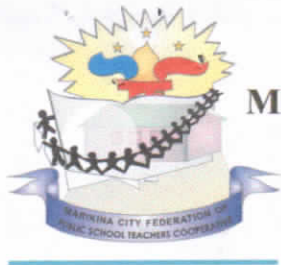
Participants are the Chairpersons of the different primary teacher cooperatives in the Division and the Officers of the MCFPSTC.

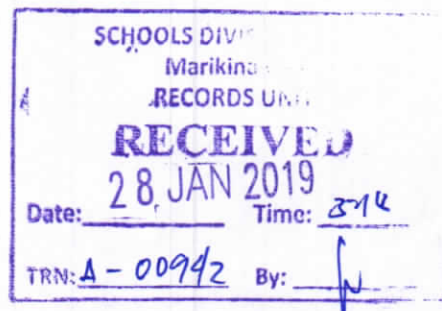
