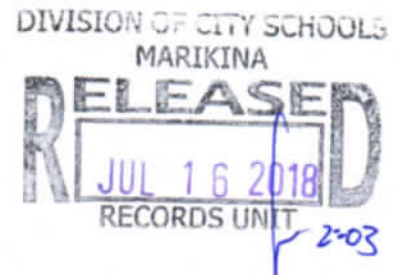

### POSTER MAKING CONTEST GUIDELINES

1. All participants are entitled to ONE coach or chaperon
2. Contestants per school are advised to bring their own 20" x 30" illustration boards which will serve as their canvass. The name and school of the participants should be pasted at the back of the board.
3. Schools will provide their own basic drawing and coloring materials such as crayons, oil pastels, coloring pencils, water colour, poster paints and markers.
4. After the announcement of the theme of the contest, the participants are given five (5) minutes to consult with the coaches. After that the participants are given two (2) hours to work on their entries. No more coach or chaperone interference is allowed during this period.
5. The art shall follow a PORTRAIT orientation. No text or mark identifying the participants should appear on the artwork
6. Rescue 161-DRRMO shall display a wall or digital clock so that participants are guided on the time limitations.
7. After the contest work period, all entries will be submitted to Rescue 161-DRRRMO
8. Panel of Judges shall be composed of the following:
  - Chairperson :DEPED Representative
  - Members :Rescue 161 DRRMO Representative  
:PIO Representative  
:DILG Representative  
:SRMG Representative
  - Tabulator :Rescue 161-DRRMO
9. Entries will be judged on the following criteria:
 

• Overall presentation, creativity, color harmony etc.-	50%
• Relevance to the theme -	40%
• Originality-	10%
TOTAL	100%
10. After the adjudication and tabulation of the results, the Panel of Judges shall announce and award the winners of the contest. The decision of the Panel shall be final.
11. Winners will receive the following prizes:
  - 1<sup>st</sup> Place-Php 5,000.00
  - 2<sup>nd</sup> Place- Php 4,000.00
  - 3<sup>rd</sup> Place -Php 3,000.00
