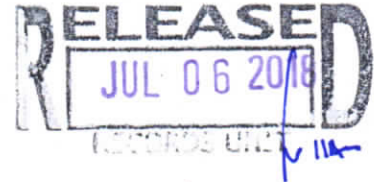



The Collective Negotiating Agreement that the ACT-NCR Union and DepEd NCR has entered into last May 26, 2015 has lapsed. The DepEd Teachers' Union is requesting to be given the sole authority to represent teachers.

The DepEd Teachers Union presented a petition for certification election to the Department of Labor and Employment-Bureau of Labor Relations (DOLE-BLR) in order to determine the SENA for 2018-2020.
