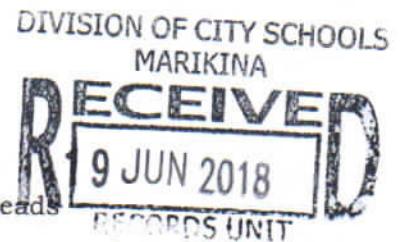

**CHANGE IN THE REPRESENTATION OF THE DEPARTMENT OF EDUCATION IN
THE PALARONG PAMBANSA BOARD**

To: Undersecretaries
Assistant Secretaries
Regional Secretary, ARMM
Bureau and Service Directors
Regional Directors
Schools Division Superintendents
Public and Private Elementary and Secondary School Heads
All Others Concerned



1. Republic Act No. (RA) 10588, or the *Palarong Pambansa* Act of 2013, and its Implementing Rules and Regulations (IRR), provided for the following composition of the *Palarong Pambansa* Board:

- a. Secretary of the Department of Education (DepEd) as Chairperson;
- b. Four (4) Undersecretaries of DepEd to be identified by the Secretary;
- c. Three (3) Assistant Secretaries of DepEd to be identified by the Secretary;
- d. Chairman of the Philippine Sports Commission (PSC); and,
- e. Secretary of the Department of the Interior and Local Government (DILG).

2. With recent changes in the appointments of DepEd Undersecretaries and Assistant Secretaries, the DepEd representation in the *Palarong Pambansa* Board is now composed of five (5) Undersecretaries and one (1) Assistant Secretary, in addition to the Secretary as Chairperson.

3. To conform to the provisions of RA 10588 and its IRR, the DepEd representation to the *Palarong Pambansa* Board is hereby changed as follows:

a. Four (4) Undersecretaries:

Undersecretary Nepomuceno A. Malaluan
Undersecretary Alain Del B. Pascua
Undersecretary Annalyn M. Sevilla
Undersecretary Jesus L. R. Mateo

b. Three (3) Assistant Secretaries

Assistant Secretary Revsee A. Escobedo
Assistant Secretary Josephine G. Maribojoc
Assistant Secretary G.H. S. Ambat

4. The Secretary, as Chairperson, shall at the soonest convene a meeting of the *Palarong Pambansa* Board to appoint a new Secretary General in light of the change in DepEd representation.
5. This Memorandum shall take effect immediately.
6. All provisions in DepEd Orders, Memoranda, and other related issuances, which are inconsistent with this Memorandum are hereby repealed, rescinded, or modified accordingly.
7. Immediate dissemination of this Memorandum is desired.
