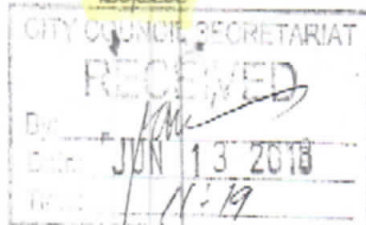

**WHEREAS**, despite the best efforts of parents to promote healthy eating to their families, their children still patronize junk food and sugary drinks;

**WHEREAS**, health experts express concern regarding the volume and poor nutritional quality of foods and beverages marketed to school children;

**WHEREAS**, nearly all foods being bought by the children in schools have high level of calories, total fat, saturated fat, sugar and sodium which are calorie-dense, nutrient poor-foods or simply known as junk foods and sugar-based drinks;

**WHEREAS**, these children should be protected from exposure to these unhealthy foods through legislation and the enforcement of the legislative measure in order to discourage the purchase and consumption of nutritionally poor foods and sugary drinks by the schoolchildren;

**WHEREAS**, in order to promote a healthy diet and positive eating behavior and provide healthy eating environment to learners and to its teaching and non-teaching personnel, the Department of Education has issued last March 17, 2017 Department Order No. 13 providing the policy and guidelines on healthy food and beverage choices in schools and all department offices;

**NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE MEMBERS OF THE SANGGUNIANG PANLUNGSOD OF MARIKINA** in session assembled that: -

**SECTION 7. Repealing Clause.** - Any provision of ordinance, rules and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby repealed and/or modified accordingly.

**SECTION 8. Separability Clause.** - Should any portion or provisions of this ordinance be declared unconstitutional or invalid, the other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.


**SECTION 9. Effectivity.** - This Ordinance shall take effect immediately upon its approval.
