

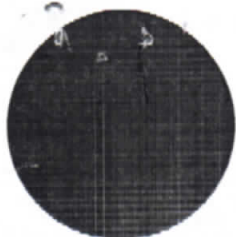

SEC is designed for officials holding permanent Directorship positions including Assistant Directors or their equivalents, with SG 25 and above, aged 55 years old or younger, and in good health. OICs of third level positions are also eligible.
