SUBJECT: *Submission of Off-campus Activities in Aid of House Bill 2117*

DATE: 28 January 2020

Representatives of the Department attended the hearing of the Committee of the Basic Education and Culture of the 18th Congress to discuss House Bill 2177 re: An Act Mandating the Inclusion of Visits to Historical and Cultural Heritage Sites as Part of the Off-Campus Activities of Public and Private Schools, Amending for the Purpose Republic Act No. 10066, otherwise known as the "National Cultural Heritage Act of 2009" on 28 January 2020 at the House of Representatives, Batasan, Quezon City. The house bill seeks the prioritization of historical and cultural sites in off-campus activities.

During the committee hearing, the representatives noted DepEd Order 66 s. 2017: Implementing Guidelines on the Conduct of Off-campus Activities which states that "Apart from relevance to the curriculum, local sites of academic and/or historical relevance should be prioritized to promote local knowledge sources and cost-efficiency in determining the venue for field trips/education tours" (Sec. VII, para C). Consequently, the Committee requested the Department to submit a list of sites of off-campus activities in aid of the development of the house bill.

In this regard, Regional Offices are requested to submit off-campus activities conducted during School Years 2018-2019 and 2019-2020 of public and private elementary and secondary schools using the attached annex as template.
