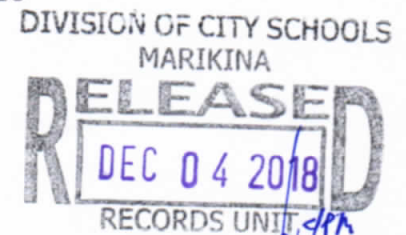

1. Enclosed is DepEd Order No. 049, s. 2018 entitled **Amendments to DepEd Order No. 25, s. 2018 (School Calendar for School Year 2018 – 2019)**, the content of which is self-explanatory, for information and guidance of the field.
2. Particular attention is invited to paragraph nos. 2-4 of the said DepEd Order concerning the amendments for the original Christmas break from December 22, 2018 to December 15, 2018 which is stipulated in DepEd Order No. 25, s. 2018, resumption and last day of classes on January 2, 2019 and April 5, 2019 respectively and directing all Regions, SDOs & Schools to review the Budget of Work (BOW) on curriculum implementation to ensure that the required competencies be covered.
3. The private schools may deviate from this guidelines since they have their own calendar of activities based on DepEd Order No. 25, s. 2018 and provided that they have already communicated/consulted with their parents/stakeholders prior to the issuance of this Order.
4. The public schools must adhere to this policy particularly on Christmas Party of students and teachers which is on December 15, 2018.

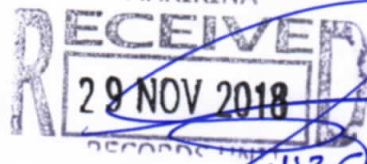
