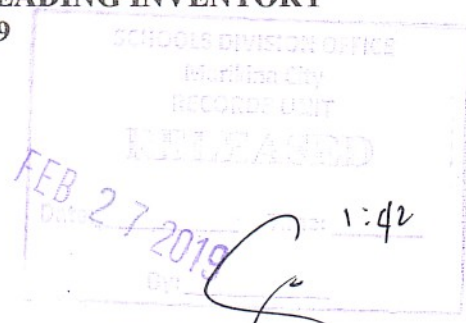

 (PHIL-IRI) POST TEST SY 2018-2019**

- In accordance with DepEd Order No. 014, s. 2018 which is the “Policy Guidelines on the Administration of the Revised Philippine Informal Reading Inventory,” this Division will spearhead the simultaneous conduct of **Phil-IRI Post Test** in all elementary schools.
- This activity aims to re-assess the learners’ reading performance both in Filipino & English after receiving specialized instruction/intervention.
  - Filipino - Gr. 3 to 6 pupils
  - English - Gr. 4 to 6 pupils
- The reading materials and various forms to be accomplished will be reproduced by the target school.
- The **Phil-IRI Oral Reading Test (ORT)** will be conducted on **opposite sessions**. School Heads of the target schools are requested to make necessary arrangements on the participation of teacher-examiners to avoid disruption of classes.
