

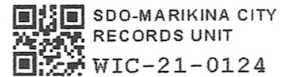

11. Amang Rodriquez Memorial Medical Center


