**RESOLUTION TO AWARD THE PROVISION OF MAKESHIFT SHOWER ROOMS
AT PARANG HIGH SCHOOL TO MT. GUITING-GUITING CONSTRUCTION**

February 21, 2020

Whereas, the Schools Division of Marikina City had posted on its bulletin board and advertised in its website and in the PhilGEPS website from February 13-17, 2020, the **REQUEST FOR QUOTATION** for the “*Provision of Makeshift Shower Rooms at Parang High School*” with an Approved Budget for the Contract (ABC) amounting to *Nine Hundred Ninety-Nine Thousand Two Hundred Eighty Pesos and Eighty-Eight Centavos (₱ 999,280.88)*;

Whereas, until the scheduled Opening of Quotation on February 17, 2020, the Bids and Awards Committee (BAC) received one (1) bid from **Mt. Guiting-Guiting Construction** with an offer of **Php 997,131.04**, which is less than the Approved Budget for the Contract (ABC);

Whereas, the bid of **Mt. Guiting-Guiting Construction** was found to be substantially **COMPLYING** during the Opening of Bids and emerged as the **LONE CALCULATED BID** after the detailed evaluation by the BAC on January 19, 2020;

Whereas, the bid of **Mt. Guiting-Guiting Construction** was found to be **RESPONSIVE** after the conduct of Post-Qualification by the Bids and Awards Committee on February 20, 2020;

Wherefore, upon thorough examination, evaluation and deliberation of the **POST-QUALIFICATION** results, the members of the Bids and Awards Committee unanimously approved to recommend to the Officer-in-Charge, Office of the Schools Division Superintendent, **MS. SHERYLL T. GAYOLA** to award the contract for the “*Provision of Makeshift Shower Rooms at Parang High School*” to **Mt. Guiting-Guiting Construction**;


Resolved, as it is hereby resolved, to recommend to the Officer-in-Charge, Office of the Schools Division Superintendent, **MS. SHERYLL T. GAYOLA** to award the contract for the above project to **Mt. Guiting-Guiting Construction** in the amount of **Nine Hundred Ninety-Seven Thousand One Hundred Thirty-One Pesos and Four Centavos (Php 997,131.04)**;


